

Notice of Solid Waste Facility Review

Public Notice is hereby issued, pursuant to MGL Chapter 111, Section 150A and 150A½, and the regulations at 310 CMR 16.00, that the Holyoke Sanitary Landfill Inc. has submitted a Site Assignment application for the purpose of installing a leachate storage tank to the Massachusetts Department of Environmental Protection ("MassDEP"), the Massachusetts Department of Public Health, and the South Hadley Board of Health.

Proponent: Holyoke Sanitary Landfill, Inc., 4 Technology Drive, Westborough, MA 01581

Location: Bartlett Street, South Hadley, Massachusetts

Type of Facility: The proposed area to be Site Assigned will contain a leachate storage tank and associated appurtenances for leachate storage, conveyance and discharge.

Size of Facility: The proposed project will not provide any increase in waste disposal capacity at the Granby Sanitary Landfill. The area to be Site Assigned is 2.3 acres.
