NOTICE: PUBLIC HEARINGS FOR VEGETATION MANAGEMENT PLAN

Pursuant to the Rights-of-Way Management Regulations (333 CMR 11.00) in order to apply pesticides to control vegetation to maintain Rights-of Ways, the Department of Agricultural Resources must approve a Vegetation Management Plan (VMP) and a Yearly Operational Plan (YOP). The VMP is intended to justify the need to control vegetation, identify target vegetation, describe the intended methods of control, describe methods for identifying sensitive areas, describe operational guidelines for applicators, outline a program of Integrated Pest Management (IPM) designed to reduce the use of herbicides, and describe alternative land use activities.

The following municipalities are advised that TransCanada Hydro Northeast, Inc proposes to utilize herbicides to treat their Rights-of-Way:

Buckland, Florida, Monroe

PUBLIC HEARINGS SCHEDULED:

In accordance with 333 CMR 11.05 the Department of Agricultural Resources will conduct a regional hearing to receive public comment on the proposed Vegetation Management Plan for the TransCanada Hydro Northeast, Inc. as submitted by the TransCanada Hydro Northeast, Inc and prepared by Vegetation Control Service Inc.

To provide all interested parties an opportunity to comment on the proposed VMP, public hearings will be held at the following location:

Buckland Town Hall, Meeting Room 1, 17 State Street, Buckland, MA, Shelburne Falls on June 1, 2007 from 10:30 am – 12:00 pm.

Plans Available for Public Review Prior to Hearings:

Section 11.05 (3)(d) of the Row Management Regulations provide: "At least 21 days prior to the end of the public comment period, the applicant shall send a copy of the proposed VMP to the chief elected official, the Board of Health, and the Conservation Commission in affected communities upon their request."
