The U.S. Department of Commerce/National Oceanic and Atmospheric Administration is proposing to dredge approximately 47,000 to 103,000 cubic yards of predominately-sandy material from the Great harbor entrance channel and approximately 25,800 to 34,900 cubic yards of silty-sand from the inner harbor.
