This office represents the Shops at Saugus, LLC, the Proponent of the above described Project. Our office has been working with Rick Salvo of Engineering Alliance throughout the permitting and construction process.

At the bottom of Page 3, the above described Final Record of Decision provided the following:

As a condition of the DROD, I require that the proponent submit the final land conveyance package to the MEPA Office for notice in the <u>Environmental Monitor</u>.

We have completed all the land conveyances contemplated by the Special Legislation and therefore I am enclosing copies of the instruments recorded in the Essex South Registry District Registry of Deeds. All of the parcels of land are described or referred to in the special legislation with the exception of the land described in No. 14 which were conveyed to satisfy the "No Net Loss Policy".

#### **MWRA EASEMENT RELOCATION:**

The Proponent relocated an existing 36" water main for the Massachusetts Water Resources Authority ("MWRA").

On May 3, 2007, Shops at Saugus, LLC executed a certain MITIGATION COVENANT which restricted development and created a landscape buffer on a portion of the property to be conveyed to Shops at Saugus, LLC.

### **APPRAISALS AND CASH PAYMENTS:**

DCAM ordered appraisals on each of the parcels of land described in the special legislation which were to be conveyed to the Commonwealth by Shops at Saugus, LLC and by the Commonwealth to Shops at Saugus, LLC. Shops at Saugus, LLC paid the Commonwealth the net amount due of \$3,405,000 at the closing.
