Schedule for Preparation of Water Needs Forecasts for Public Water Suppliers with Water Management Act Permits

Public water suppliers and communities who plan to either renew existing Water Management Act (WMA) permits or submit new permit applications to the Massachusetts Department of Environmental Protection (MassDEP) must include a 20-year forecast of water needs with their permit applications. Public water suppliers and communities should obtain such forecasts from the Water Resources Commission. Staff in the Department of Conservation and Recreation. Office of Water Resources, prepare these forecasts in accordance with the Commission's *Policy* for Developing Water Needs Forecasts for Public Water Suppliers and Communities and Methodology for Implementation (Dec. 13, 2007), available at http://www.mass.gov/envir/mwrc/pdf/121307 waterneedsforcast.pdf.

Forecasts are being developed in coordination with MassDEP's WMA permit renewal schedule and deadlines. The following is the schedule for forecasts currently in progress.
