Notice is hereby given that the Department of Environmental Protection, acting in accordance with the provisions of M.G.L. chapter 111, Section 142A through 142E, will offer for public comment the following draft Operating Permit with Significant Modification issued pursuant to 310 CMR 7.00: Appendix C.

The draft Operating Permit with Significant Modification is being issued in accordance with 310 CMR 7.00: Appendix C(6). The purpose of the draft Operating Permit with Significant Modification is to incorporate the federally enforceable hazardous air pollutant emission (HAPs) limits imposed in the Final Restricted Emission Status Approval issued to the Lawrence facility on January 24, 2006. This action is required by the U.S. Environmental Protection Agency as stated in its final rule approving the Department's Operating Permit program (Federal Register Vol. 61, No. 95 Wednesday May 15, 1996).

Based on the written request, the Department will determine if a public hearing will be held and a 30 day written notice will be given.
