
## Notice of License Application pursuant to M. G. L. Chapter 91 Waterways License Application Number W07-1996D Riverview Marina

Public notice is hereby given of the application by Riverview Marina to perform maintenance dredging of approximately 4, 355 cubic yards of subaqueous material at 58 River Street in the municipality of Danvers in flowed tidelands of the Porter River. This proposed dredging project is intended to piggyback with the proposed Town of Danvers dredge project. The dredged material will be taken to the Massachusetts Bay Disposal Site for final disposal. The proposed use of the project is to provide for improved access to navigable waters and is a water dependent project.



Failure of any aggrieved person or group of ten citizens or more to submit written comments to the Waterways Regulation Program by the Public Comments Deadline will result in the waiver of any right to an adjudicatory hearing in accordance with 310 CMR 9.13(4)(c).
