## Schedule for Preparation of Water Needs Forecasts for Public Water Suppliers with Water Management Act Permits

Public water suppliers and communities who plan to either renew existing Water Management Act (WMA) permits or submit new permit applications to the Massachusetts Department of Environmental Protection (MassDEP) must include a 20-year forecast of water needs with their permit applications. Public water suppliers and communities should obtain such forecasts from the Water Resources Commission. Staff in the Department of Conservation and Recreation (DCR), Office of Water Resources, prepare these forecasts in accordance with the *Policy for Developing Water Needs Forecasts for Public Water Suppliers and Communities and Methodology for Implementation* (May 1, 2009), available at the web site of the Water Resources Commission.

Forecasts are being developed in coordination with MassDEP's WMA permit renewal schedule and deadlines. DCR is developing forecasts for public water supply systems (PWS) in the **Boston Harbor Basin** (Mystic, Neponset, Weymouth and Weir Rivers) and the **Taunton River Basin**. The existing WMA permits for these systems expire on *February 28, 2010*. The target date for DCR to provide final projections to PWSs is *October 9, 2009*. The window for a PWS to submit its permit renewal application is *November 1 – 30, 2009*.

INFORMATION THAT MAY BE USEFUL IN DEVELOPING FORECASTS SHOULD BE PROVIDED TO DCR NO LATER THAN **SEPTEMBER 10, 2009**.
