Water Management Act Permit Application Received by the Department of Environmental Protection Southeast Regional Office For the Cape Cod Coastal Drainage Area

The Department of Environmental Protection will accept written comments on the Water Management Act (WMA) application filed for permitting in the Cape Cod Coastal Drainage Area. The permit requested would authorize water withdrawals through November 30, 2010 under the Water Management Act, M.G.L. c.21G. Comments must be submitted by close of business on Tuesday, **September 26, 2006** to the Department of Environmental Protection, Southeast Regional Office, 20 Riverside Drive, Lakeville, Massachusetts 02347, Attention: Leslie O'Shea, or via e-mail to leslie.o'shea@state.ma.us.

An application for a WMA permit has been filed by the Bourne Water District, P.O. Box 1447, Pocasset, MA 02559. Bourne Water District (BWD) is currently authorized to withdraw an average daily volume of 0.73 MGD (million gallons per day) under WMA Registration #422036.02 and 0.67 MGD under WMA Permit #9P422036.01, for a total average daily withdrawal volume of 1.4 MGD, or 511.0 MGY (million gallons per year). BWD is requesting to increase the WMA authorized volume from 1.4 MGD to 1.52 MGD (or 554.8 MGY) through the permit end date of November 30, 2010. No additional withdrawal points are requested by this permit application.

In 2004 the Bourne Water District absorbed the South Sagamore Water District. Because South Sagamore's water source was inactive at the time of transfer, and may not be reactivated, BWD did not receive the registered volume for South Sagamore's source. BWD is now applying for 0.12 MGD to ensure sufficient water supply for the expanded district.
