Subject: Notification of Minor Modification to Final Operating Permit No. 4V95067 - Fall River Landfill

In accordance with 310 CMR 7.00, Appendix C(8)(d) of the Massachusetts Air Pollution Control Regulations, the Department of Environmental Protection (the Department) is notifying you of a pending Minor Modification to Final Operating Permit No. 4V95067 -- Browning Ferris Industries, Inc., Fall River Landfill, 1080 Airport Road, Fall River, MA.

On August 18, 2008, the Department received a BWP AQ10 Minor Modification application requesting modifications to Final Operating Permit No. 4V95067 to incorporate changes included in Conditional Approval No. 4P06034, dated June 20, 2008.

As is currently described in Final Operating Permit No. 4V95067, the Fall River Landfill includes two emission units: a municipal solid waste (MSW) landfill with a design capacity of 8.1 megagrams of solid waste (Emission Unit No. EU-1) and a paint spray booth (Emission Unit No. EU-2). Emission Unit EU-1 refers to the Phases 1 and 2 landfill areas, now closed and capped. This emission unit utilizes a gas collection system and 2 enclosed landfill gas flares to collect and combust landfill gas (LFG) generated within the waste mass.

Conditional Approval No. 4P06034 provides for the following:

- 1. Addition of a new Phase 3 landfill expansion area as a new emission source, identified as Emission Unit No. EU-3.
- 2. Revised fugitive emissions from the original Phase 1 and 2 landfill areas plus the potential for fugitive emissions from the new Phase 3 landfill area.
- 3. Revised sulfur oxide emissions from the 2 enclosed LFG flares.
