Public notice is hereby given of the Waterways application by the Old North Wharf Co-Op to realign and reconstruct an existing catwalk, existing pier, extension to existing pier, upgraded utilities (sewer, water, electrical, telecommunications) and to construct and maintain a ramp and float, wave fence and pump out facility, at Old North Wharf in the municipality of Nantucket in and over flowed and filled tidelands of Nantucket Harbor. The proposed project has been determined to be water-dependent.

The Department will consider all written comments on this Waterways application received by within 30 days subsequent to the "Notification Date". Failure of any aggrieved person or group of ten citizens or more to submit written comments to the Waterways Regulation Program by the Public Comments Deadline will result in the waiver of any right to an adjudicatory hearing in accordance with 310 CMR 9.13(4)(c).
