The project site has been used for industry for many years. The proponent is renovating the existing buildings to accommodate a marine fabricating business. The proposed site work includes removing pavement and tanks (above ground/storage), replacing loamed areas with a flat gravel surface, paving an access way to a proposed travel lift pier, construction of piers, gangways, floats and appurtenant facilities.
