Public notice is hereby given of the Waterways application by Neptune LNG, LLC to construct and maintain a natural gas pipeline within the Commonwealth and municipalities of Manchester-by-the-Sea, Beverly, Salem, and Marblehead in, over, and under Flowed Tidelands of Massachusetts Bay. The pipeline is to be partially located in the North Shore and South Essex Ocean Sanctuaries. The proposed structures are associated with the Neptune LNG Deepwater Port proposed in waters beyond the boundary of the Commonwealth. The proposed project has been determined to be water-dependent. The applicant's representative is Ecology and Environment, Inc, 14411 Commerce Way, Suite 350, Miami Lakes, FL.

The Department of Environmental Protection, Waterways Regulation Program, will conduct a public hearing on the aforesaid project proposal on Wednesday, March 21, 2007, at 6:00 PM at the National Park Service-Salem Visitor Center, 2 New Liberty Street, Salem. The Department will conduct this public hearing in order to receive information to be used in its decision on whether to grant a Waterways License pursuant to M.G.L. Chapter 91.

The Department will consider all written comments on this Waterways application received by April 11, 2007 (Public Comments Deadline). Failure of any aggrieved person or group of ten citizens or more to submit written comments to the Waterways Regulation Program by the Public Comments Deadline will result in the waiver of any right to an adjudicatory hearing in accordance with 310 CMR 9.13(4)(c).
