

**NOTICE OF SITE RECLASSIFICATION AND APPLICATION
FOR TIER I PERMIT**

**Former Mobil Service Station 01-602
731 Main Street
Harwichport, Massachusetts

Pursuant to the Massachusetts Contingency Plan (310 CMR 40.0530), a re-evaluation of the disposal site using the Numeric Ranking System has been performed at the above referenced location. A release of oil and/or hazardous materials has occurred at this location which is a disposal site (as defined by M.G.L c. 21E, Section 2). This site has been reclassified as Tier IB (310 CMR 40.0500), and an Initial Tier IB Permit application is being submitted on or before March 28, 2006 to the Department of Environmental Protection (DEP) pursuant to 310 CMR 40.0703. A permit is required to proceed with a Comprehensive Remedial Response at all Tier I sites.

Anyone interested in reviewing the Permit Application should notify Elizabeth Zinkevicz of Mobil Business Resources Corporation, 52 Beacham Street, Everett, Massachusetts, 02149, (617) 381-2851, to request a copy of the Permit Application. Interested persons may submit written comments related to the Permit Application within 21 days of this legal notice publication date. The comments shall be submitted to (1) the Permit Applicant at the address provided above; and (2) DEP, Bureau of Waste Site Cleanup, Permit Section, DEP Southeast Regional Office, 20 Riverside Drive Lakeville, Massachusetts 02347 by mail or by hand delivery during normal office hours. Anyone who fails to notify DEP in writing of his/her interest in commenting on the application by the above deadline may be deemed to have waived his/her rights, if any, to appeal DEP's permit decision or to intervene in an adjudicatory proceeding with respect to this application, pursuant to 310 CMR 40.0770.

M.G.L. c. 21E and the Massachusetts Contingency Plan provide additional opportunities for public notice of and involvement in decisions regarding response actions at disposal sites: 1) The Chief Municipal Official and Board of Health of the community in which the site is located will be notified of major milestones and events, pursuant to 310 CMR 40.1403; and 2) Upon receipt of a petition from ten or more residents of the municipality in which the disposal site is located, or of a municipality potentially affected by a disposal site, a plan for involving the public in decisions regarding response actions at the site will be prepared and implemented, pursuant to 310 CMR 40.1405.
