**NOTICE OF MCP PHASE IV REMEDY IMPLEMENTATION PLAN  
FORMER UNDERGROUND STORAGE TANK (FUST) SITE 1  
104 TH FIGHTER WING  
MASSACHUSETTS AIR NATIONAL GUARD  
BARNES MUNICIPAL AIRPORT  
WESTFIELD, MASSACHUSETTS

A Phase IV Remedy Implementation Plan (RIP) has been developed for the above site pursuant to the Massachusetts Contingency Plan (MCP – 310 CMR 40.0874), and this notice has been prepared for compliance with the Massachusetts Environmental Policy Act as required by the MCP at 310 CMR 40.1406.

FUST Site 1 is located adjacent to the Base administration building at the Barnes Air National Guard Base, in Westfield, Massachusetts. The Site has been assigned the Number (RTN) 1-0288 and is currently classified as a Tier 1A site.

In January 2004 an MCP Phase III Remedial Action Plan (RAP) for FUST Site 2 was prepared by the ANEPTEK Corporation on behalf of the Air National Guard (ANG), and submitted to the DEP. The Phase III RAP proposed the following measures to respond to a release of oil and/or hazardous material at this disposal site:

- Enhanced fluid recovery using high-vacuum vapor extraction (EFR/SVE), and
- Enhanced insitu biodegradation using oxygen – releasing compound (ORC).

A phase IV Remedy Implementation Plan (RIP) was subsequently prepared which provides the design, implementation, operation, and maintenance details for the selected remedial alternative for FUST Site 1. The Phase IV report was prepared by Science Applications International Corporation (SAIC) on behalf of the ANG. The Phase IV RIP document has been filed at the Massachusetts Department of Environmental Protection's Western Regional Office, 436 Dwight Street, Springfield, Massachusetts.

Chapter 21E of MGL and the MCP provide additional opportunities for public notice of and involvement in decisions regarding response actions at disposal sites: 1) the Chief Municipal Official and Board of Health of the community in which the site is located will be notified of major milestones and events, pursuant to 310 CMR 40.1403; and 2) upon receipt of a petition from ten or more residents of the municipality in which the disposal site is located, or of a municipality potentially affected by the disposal site, a plan for involving the public in decisions regarding response actions at the site will be prepared and implemented, pursuant to 310 CMR 40.1405.
