
Public notice is hereby given of the Waterways application by the China Trust to license – an existing 50 foot by 30 foot pile supported pier surrounded by a timber fence, on which are located a 20 foot by 16 foot retail building with the remainder of the pier area devoted to use as a deck (240 square feet of which is for public use and the remaining 940 square feet of which is devoted to private use), a 4 foot by 4 foot set of stairs to the beach, a 12 foot by 2 foot concrete walkway to the private deck, a 94 foot long public accessway to the beach varying from 4 feet to 2 feet in width, and existing dinghy tie-up pilings at 361 Commercial Street in the municipality of Provincetown in and over Filled and Flowed Tidelands of Provincetown Harbor. The proposed project has been determined to be nonwater-dependent.

Failure of any aggrieved person or group of ten citizens or more to submit written comments to the Waterways Regulation Program by the Public Comments Deadline will result in the waiver of any right to an adjudicatory hearing in accordance with 310 CMR 9.13(4)(c).


