**1.0 PREPARATION OF FINAL CWMP/EIR**

**A. PREPARATION OF FINAL CWMP/EIR**

The Final CWMP/EIR will address any unresolved issues in the Draft CWMP/EIR. It will provide further detail where necessary and address any comments received on the Draft CWMP/EIR.

1. Archaeological Assessment to be conducted on all sites previously tested.

**2.0 PUBLIC PARTICIPATION**

Throughout Phase IV, the public participation program will be implemented. A public hearing is required to present the Final CWMP/EIR.

**A. PUBLIC PARTICIPATION**

During Phase IV, the public participation program will consist of: 1) arranging and making a presentation at one public hearing; 2) publishing of “responsiveness summaries of all formal public meetings and hearing; and 3) regular meetings with the CAC.

**3.0 SRF LOAN APPLICATION**

- A.** Grant/Loan administration services will be provided in accordance with EPA/DEP financial assistance guidelines and procedures. Liaison between the Town and DEP officials, and contract administration will be included. The Town of Foxborough will provide assistance in this area.


