In accordance with Massachusetts General Laws, Chapter 111, Section 150A and 150 A 1/2 and the regulations promulgated thereunder, 310 CMR 16.00 "Site Assignment Regulations for Solid Waste Facilities," an application has been filed with the Town of Raynham Board of Health by National Reclamation of Raynham, LLC, 1958 Broadway (Route 138), Raynham, Massachusetts 02767 for the site assignment of a parcel of land for a solid waste handling facility. The land parcel is located at 1958 Broadway (Route 138), Raynham, MA and is adjacent to the site of the Raynham/Taunton Greyhound park racetrack.

The area under consideration encompasses approximately 6 acres. The proposed waste acceptance rate is 1,000 tons/day of municipal solid waste and construction and demolition material.

The Department of Environmental Protection will accept comments on the proposed Site Assignment Application for twenty-one (21) days from the date of the Department's receipt of proof that the public notice requirements have been completed. The applicant may modify the application for the initial forty (40) days of the review period where such modifications are deemed not to be major modifications. The Department shall issue

a Department Report on Suitability within sixty (60) days of the date of the Department's receipt of proof that the public notice requirements have been completed.
