Draft Mount Everett Summit Resource Management Plan Available for Public Review

The mission of the Department of Conservation and Recreation (DCR) is to exercise care and oversight for the natural, cultural, and historic resources of the Commonwealth and to provide quality public outdoor recreational opportunities that are environmentally sustainable, affordable, and accessible to all citizens.

DCR prepared the Mount Everett Summit Resource Management Plan in recognition of the globally unique natural resources and to guide management activities occurring on the summit of Mount Everett (located within the Mount Everett State Reservation in the Town of Mt. Washington, and partially located within the Schenob Brook Area of Critical Environmental Concern). The Plan also has been prepared to fulfill the provision of the EOEA Certificate (#12230, dated July 26, 2002) directing the Department to prepare a resource management plan for the summit of Mount Everett.

The overall goal of the plan is to protect the unique natural resources of the Mount Everett summit environment and to provide public access and recreation compatible with this stewardship responsibility. A significant amount of research has been conducted by pre-eminent scientists on the natural resources of Mount Everett. This Plan summarizes these field studies to frame the Plan's management goal and objectives to protect the natural resources on the summit. Key natural resources include dwarf pitch pine forest, habit for rare moths, old growth forest and other unusual vegetation characteristic of the summit's ecology.

The Plan develops a clear overall management goal for the summit, articulates management objectives and environmental indicators to be used to judge if the vision has been achieved. The summit planning area is the 35-acre summit area located above the 2500 foot contour elevation and a 70-acre summit area buffer zone located between the 2400 and the 2500 foot contour elevation.

Based on the input of scientists, local officials, interested citizens, public agencies and private organizations, the stewardship recommendations address natural resource protection and monitoring, public safety, public access, and interpretive opportunities.

A public meeting regarding the draft Plan is scheduled for:

Monday, November 7, 2005, at 7:00pm in the Town of Mount Washington Town Hall.
