Public notice is hereby given of the Waterways application by Wharf Street LLC to construct and maintain a six story mixed-use building with below-grade and surface parking and site drives, and to construct a continuous waterfront public walkway spanning three parcels, an adjacent waterfront park and improvements to the current seawall condition in the municipality of Milton on Filled Tidelands of the Neponset River. The proposed project has been determined to be nonwater-dependent.

The Department of Environmental Protection, Waterways Regulation Program, will conduct a public hearing on the aforesaid project proposal on **Tuesday, November 5, 2002 at 2:30 p.m. in the Large Basement Conference Room of the Milton Town Hall**. The Department will conduct this public hearing in order to receive information to be used in its decision on whether to grant a Waterways License pursuant to M.G.L. Chapter 91.

The Department will consider all written comments on this Waterways application received by November 27, 2002 (Public Comments Deadline). Failure of any aggrieved person or group of ten citizens or more to submit written comments to the Waterways Regulation Program by the Public Comments Deadline will result in the waiver of any right to an adjudicatory hearing in accordance with 310 CMR 9.13(4)(c).
