Public notice is hereby given of the Waterways application by Partners HealthCare Systems, Inc. to maintain existing parking areas and existing buildings for use associated with maintenance of its vehicle fleet in the Mystic River Designated Port Area in the municipality of Boston (Charlestown). The proposed project has been determined to be a nonwater-dependent use project. The proponent's consultant is Epsilon Associates, Inc., 3 Clock Tower Place, Maynard, MA.

The Department of Environmental Protection (DEP), Waterways Regulation Program, will conduct a public hearing on the aforesaid project proposal on Monday December 22, 2008, at 11:00AM in Conference Room C, 2nd Floor, at the DEP offices at One Winter Street, Boston. The Department will conduct this public hearing in order to receive information to be used in its decision on whether to grant a Waterways License pursuant to M.G.L. Chapter 91.

The Department will consider all written comments on this Waterways application received by January 12, 2009 (Public Comments Deadline). Failure of any aggrieved person or group of ten citizens or more to submit written comments to the Waterways Regulation Program by the Public Comments Deadline will result in the waiver of any right to an adjudicatory hearing in accordance with 310 CMR 9.13(4)(c).
