The existing building at 333 ^(Building 2) Commercial Street, Provincetown, borders on Provincetown Harbor. The existing building requires a Chapter 91 License. The property includes past filled tidelands. The historic mean highwater line is shown on the plan. This lot lies within Zone A4 (elevation 11). Building 2 lies within land classified as the historic mean highwater line. Refer to site plan by William N. Rogers II, P.E. dated 6-23-04. Approximate size of Building 2 is 3,200 sq. ft. The lot area is 11,660 sq. ft.
