The Town of Yarmouth is proposing to maintenance dredge (-6 feet Mean Low Water, pay –7 feet Mean Low Water) the Englewood Channel, and Pine Island Entrance Channel and beach nourish Englewood Beach and other adjacent local beaches. Also included within this project is the maintenance dredging of the Englewood Boat Ramp basin, which is the seaward basin associated with the launch ramp, to pay depth at a 3 to 1 slope (please refer to Chapter 91 License Permit #918 enclosed) and maintenance dredging of the Englewood Mooring Basin. The dredge spoils will be dewatered at Englewood Beach and used as beach nourishment as needed at locus. Excess dredge spoils will be trucked to adjacent area beaches and used for beach nourishment according to the site-specific needs. This project may be conducted on a phased timeline based on the containment volume of the stilling (dewatering) basin or basins and/or the need for local beach nourishment. Initially approximately 2,200 cubic yards of 95% compatible sand will be maintenance dredged from the Pine Island Entrance Channel. This channel is located on the National Ocean Survey Chart for Hyannis with the caption "Privately Maintained" which would indicate previous dredging has been conducted. Further the Town of Yarmouth orthophotographs (Photos CC-40S-2 and 3) detail the dredging footprint.

The Englewood Entrance Channel Maintenance Dredging will use dredge spoils as beach nourishment. Approximately 300 cubic yards are proposed for maintenance dredging from the Englewood Entrance Channel. Finally the Englewood Mooring Basin, including the previously dredged area located at the boat ramp (Waterways Permit #918), will be maintenance dredged in accordance with existing and pending permits (1,000 cubic yards to dredge depth). The dredge spoils will be dewatered on Englewood Beach and within the Englewood Beach adjacent parking area. An additional 100-foot by 60-foot dewatering site

exists adjacent to, or west, of the jetty and boaters ramp. This site could also be used as a storage site, which would hold, without excavation, up to 300 cubic yards of beach nourishment. The primary dewatering basin will be constructed out of sands excavated from the beach above Mean High Water (MHW). The basin will further be reinforced with jersey barriers or similar reinforcement on the seaward edge of the dewatering berm as needed and if necessary along New Hampshire Avenue. This dewatering basin will hold up to 2,200 cubic yards. Combined, these basins will account for approximately 70% of the total 3,500 cubic yards of proposed dredge volume to dredge depth. Because the dredge spoil is 95% (+/-) sand, it will immediately precipitate out the sand allowing for immediate beach nourishment off site. FOR MORE INFORMATION REFER TO PROJECT DESCRIPTION ATTACHED
