**The United States Environmental Protection Agency - Region 1 (EPA)** intends to issue the National Pollutant Discharge Elimination System (NPDES) Aquaculture General Permit (AQUAGP) for Concentrated Aquatic Animal Production (CAAP) Facilities and Other Related Facilities in the Commonwealth of Massachusetts (the AQUAGP also covers federal CAAP facilities in Vermont and CAAP facilities in New Hampshire). The AQUAGP establishes effluent limitations and requirements, effluent and ambient monitoring requirements, reporting requirements and standard conditions for 14 eligible industrial facilities currently covered by individual NPDES permits, 7 of which are in Massachusetts. **Town of Barnstable Department of Public Works** is proposing maintenance dredging of the Barnstable Harbor Outer and Mid-Entrance Channel as well as the Blish Point Boat Ramp Access Channel within previously authorized/dredged areas of the existing channels. The project includes beach nourishment/upland beneficial re-use and/or unconfined offshore disposal of sediment at the Cape Cod Bay Disposal Site (CCBDS). The Outer and Mid-Entrance Channels were last dredged in 2017 and the Blish Point Boat Ramp Access Channel was last dredged in 2013 as part of the Inner Harbor dredging project. Sediment will be disposed offshore at the Cape Cod Bay Disposal Site (CCBDS) and/or beneficially re-used as nourishment or re-used/disposed of at approved upland location(s) at Millway Beach, Sandy Neck Public Beach, and the Sandy Neck Cottage Area.
