

**PROJECT CHANGE DESCRIPTION** (attach additional pages as necessary). The project change description should include:

(a) The project as most recently reviewed was1) to increase the current site assigned area to encompass a larger area of the current property utilized for waste transfer purposes, 2) to increase the tonnage limit to 100 tons per day accounted 6 days per week (although the site will continue normal operations only 5.5 days per week); and 3) to increase the allowable waste to include construction and demolition debris.

(b) During the previous MEPA review, the status of Meadow Pond has not yet been determined in terms of the Riverfront Protection Act. As of a Conservation Commission ruling dated March 26, 2008, Meadow Pond has been determined to have riverine characteristics and therefore falls under the classification of a river in the terms of the Riverfront Protection Act. In the original Certificate on the ENF (dated January 9, 2008) there was a stipulation whereby if Meadow Pond was determined to fall under classification of a river, a Notice of Project Change would need to be submitted for further MEPA review.

(c)The material change shall not cause the expansion of the project or the generation of any further impacts during or after construction nor will it cause any delays in the project completion or change of the project site. This material change will, however, make it necessary for Tom Berkowitz Trucking to submit a Waiver in accordance with 310 CMR 16.40(6) of the facility specific site suitability requirement as set forth in 310 CMR 16.40(3)(d)(6). This section states that a site shall not be suitable if it is determined that the waste handling area would be within a Riverfront Area as defines by 310 CMR 10.00. The existing facility as currently permitted to operate through MA DEP is situated in a Riverfront Area (as Meadow Pond was recently determined to fit the classification of a river in accordance with the regulations) received a Site Assignment in 1997 to construct and operate the facility that exists today.

(d)This change does not require modification of the project as previously proposed. Douglas Road currently exists between the site and Meadow Pond. There are no impacts from Tom Berkowitz Trucking to Meadow Pond, nor will there be following this project.
