The proposed project is in the design phase. Both the Draft and Final EIR have been submitted for MEPA review (EOEA #13656). A Certificate on the Final EIR was issued by the Secretary on August 16, 2006. The MEPA filing includes details of the proposed on and off-site sewer facilities, along with detailed analysis of the entire project with regard to the MEPA review thresholds, in accordance with 301 CMR 11.03.

As part of the review of the Draft and Final EIR, the Department of Environmental Protection (DEP) requested the Proponent evaluate the potential of groundwater discharge on the sending parcel for the Westboro Village project. Additional soil testing and analysis was performed in order to determine whether or not there was the potential for the disposal of wastewater on-site. As a result of these studies, it was determined that an on-site system would not be feasible and that the municipal sewer alternative presented in the FEIR, would be the alternative advanced within the Notice of Project Change.

This filing of a Notice of Project Change is the request for a Phase I waiver from EOEA # 12348, for any project proposing sewer service within the Assabet River watershed. This filing includes the detailed results of this groundwater and soil studies. A summary of correspondence and meetings with DEP is also included.

The project scope entails the establishment of a mixed use Transit Oriented Development (TOD) on approximately 36 acres with access off of Gleason Street, in Westborough. All of the proposed on and off-site sewer mains are to be installed within existing rights-of-way and easements, or within land owned by the Town of Westborough.

The project proposes approximately 283 feet of 8 inch gravity sewer main to be established within the right-of-way of Gleason Street, terminating at Fisher Street, to be connected to existing municipal sewer mains.

The project also proposes approximately 2,100 feet of 12 inch force main sewer from the existing Otis

Street pumping station, connecting to an existing 30 inch gravity sewer upstream of the headworks at the Westborough-Shrewsbury WWTF. During construction, measures will be taken to avoid and/or minimize damage and disturbances to the surrounding environmental areas. Construction of the force main sewer includes horizontal directional drilling of 400 feet of the force main below the Assabet River to minimize impacts to the River. Hay bales and silt fence will be placed along the limits of work during construction, and will remain until such time as areas disturbed are restored to pre-construction conditions.

As part of the mitigation for this project the Proponent has agreed that the land transferred to the Town of Westborough (Sending Parcel) as part of the original project be transferred subject to future groundwater discharge rights as recommended by the DEP.



The attached report summarizes the history of this project, an analysis of the potential for on-site treatment and disposal of wastewater, and information on the proposed mitigation that is part of this project.
