The objective of the proposed projects is to reduce untreated CSO discharges from the existing combined sewer system and to reduce and/or eliminate the wet weather impact to the sewer collection system from storm water collected in these local combined sewer drainage areas. The EPA has issued an Administrative Order requiring the city to proceed with its overall CSO control plan and the projects discussed herein are critical components of that plan. Therefore, the purpose of this NPC is to request a waiver from further MEPA review for sewer separation in the Lincoln Street East and Lincoln Street West drainage areas, which are located within the Warren Street CSO Basin.
