THIS LOG FORM RECORDS AN UNANNOUNCED MASSDEP SITE INSPECTION AT FRAMINGHAM,133 LELAND STREET, GENERAL CHEMICAL CORP. THE PURPOSE OF THE INSPECTION WAS TO OBSERVE THE DRILLING BEING CONDUCTED AS PART OF THE DATA GAP ACTION PLAN. AT THE TIME OF THE INSPECTION, MARY CATHEY WITH GES WAS OVERSEEING THE DRILLING OF MW-106M. SPLIT SPOON SAMPLES WERE BEING COLLECTED, AND WERE OBSERVED TO BE MOSTLY SILT. WATER AND SOIL CUTTINGS MANAGED DURING THE DRILLING OF MW-106 WERE BEING DRUMMED IN PREPARATION FOR OVERNIGHT STORAGE. THE LOCATION OF MONITORING WELLS MW-115M AND MW-115D WAS INSPECTED. THESE WELLS ARE IN THE WETLAND ALONG THE CENTURY ESTATES CONDOMINIUMS. THE WELLS WERE COMPLETED SEVERAL DAYS AGO, AND SURROUNDED BY HAY BALES AND SILT FENCING. THE LOCATION OF PROPOSED MONITORING WELLS MW-107M AND MW-107R WAS INSPECTED. IT WAS OBSERVED THAT A VERY LARGE CONIFER WAS BLOWN DOWN BY HURRICANE SANDY IMMEDIATELY IN THE PATH BETWEEN 91 LELAND STREET AND THE LOCATION OF THESE PROPOSED WELLS. THE TREE WILL NEED TO BE SAWED AND MOVED TO GAIN ACCESS, OR A NEW PATH WOULD NEED TO BE MADE INTO THE WETLAND.
