MASSDEP CONDUCTED A SITE VISIT OF THE GENERAL CHEMICAL SITE ON MAY 30, 2012. JEFF CHORMANN, JACK MIANO AND RODENE LAMKIN ATTENDED FROM MASSDEP AND STEFAN SOKOL FROM GES REPRESENTED GENERAL CHEMICAL CORPORATION (GCC). JEFF CHORMANN LED A TOUR OF THE GCC PROPERTY AND FACILITY (WHICH RECENTLY CLOSED) DESCRIBING PAST OPERATIONS AND LOCATIONS OF VARIOUS STORAGE TANKS AND ACTIVITIES. HE NOTED AREAS OF THE PROPERTY THAT ARE CURRENTLY PAVED BUT WERE PREVIOUSLY EXPOSED GROUND SURFACE. THE AREAS OF HIGHEST GROUNDWATER CONTAMINATION WERE INSPECTED. THE LOCATIONS CONSIDERED TO HAVE DATA GAPS WERE OBSERVED TO EVALUATE ACCESS FOR FUTURE SAMPLE COLLECTION. SOIL AND GROUNDWATER COLLECTION WITHIN THE TANK FARM BERM WAS EVALUATED. THIS AREA HAS LIMITED SPACE FOR EQUIPMENT MANEUVERING. IT WAS NOTED THAT THE TANK FARM AREA HAS AN OVERHEAD ROOF PREVENTING USE OF A CONVENTIONAL DRILL RIG. WE WALKED THROUGH THE WAREHOUSE, THE FORMER LOADING DOCK BUILDING, AND THE LOADING RACK AREA ON THE NORTHERN PROPERTY BOUNDARY. THE SECOND HALF OF THE SITE VISIT CONSISTED OF WALKING THE PROPERTIES SOUTH AND EAST OF THE GCC PROPERTY IN AREAS KNOWN TO HAVE CONTAMINATED GROUNDWATER.
