**NOTICE OF AUDIT FINDINGS –
REMEDIAL SYSTEM INSPECTION**

Dear Mr. Haseotos:

The Massachusetts Department of Environmental Protection, Bureau of Waste Site Cleanup (MassDEP), is tasked with ensuring the timely assessment and cleanup of oil and hazardous material releases pursuant to Massachusetts General Law (MGL) Chapter 21E (Chapter 21E). The law is implemented through regulations known as the Massachusetts Contingency Plan, 310 Code of Massachusetts Regulations (CMR) 40.0000 et seq. (the MCP).

On June 4, 2010, MassDEP conducted an audit inspection (the audit) at the disposal site identified above, located at 1933 Ocean Street in Marshfield, Massachusetts (the Site). The purpose of the audit was to determine whether the remedial system implemented at the Site is operating in accordance with the MCP, the Phase IV Remedy Implementation Plan (RIP) submitted to MassDEP on March 3, 2006, and subsequent Site submittals. The purpose of this Notice is to inform you of the results of MassDEP's audit.

DETERMINATION

MassDEP has determined that there were no violations identified applicable to the installation, operation, and maintenance and/or monitoring of the remedial alternative at the Site. Therefore, no additional actions are necessary related to this audit. The Remedial System Field Screening Form (Attachment A) outlines the activities that MassDEP personnel performed during the audit and summarizes relevant treatment system information.

These findings do not: (1) apply to actions or other aspects of the Site that were not reviewed in the audit; (2) preclude future audits of past, current, or future response actions at the Site; (3) in any way constitute a release from any liability, obligation, action or penalty under M.G.L. c. 21E, 310 CMR 40.0000, or any other law, regulation, or requirement; or (4) limit MassDEP's authority to take or arrange, or to require any Responsible Party or Potentially Responsible Party to perform, any response action authorized by M.G.L. c. 21E which MassDEP deems necessary to protect health, safety, public welfare, or the environment.
